An Act empowering certain Commissioners therein mentioned, to lay out and set a Price or cause a Price to be set, controlling to the Said Parish now stands.

An Act for raising Threepence Seerling per Hogshead on all Tobacco to be experted, for purchasing Arms and Asserted, and for an immediate Supply of Arms, for the Defence of this Province.

An siet for the Enlargement of Baltimore Town, in Baltimore County, and other Purposes therein mentioned. An All for repairing and amending the Public and County Goal, in the City of Annapous.

An Act to prevent Evils arising from the entering up Judgments upon Bonas, common; called Judgment Bonds, to direct the M. nner of issuing Execusions on Loan Ofice Bonds, and to regulate certain Fies therein mentioned.

An Ast repeuling an Act of Assembly entituled, An Act to e able the Rector. Vestrymen, and Chicago pardens for the Time being, of St., Anne's Parish, in Anne Arundel County, to I ale critain Los in the City for Annapolis, in Manner and to the Uses therein mentioned; and to enable the fail Rector, Vestrymen, and Churchwardens, to lease certain hots of Land within the said City of Annapolis.

An Act for raising a flats of three Halfpence Sterring per Highead, on all Tobacco exported out of this Province, for

An Act for continuing an Act of Assembly of this Province entituled, An Act ascertairing the Gauge and Tare of Tobacco Housineads, and to prevent cutting, cropping, and detacing Tobacco taken on board onips or Vessels

An All reviving an All entituled, An All for the speedy and effectual Publication of the Laws of this Province, and for the Encouragement of Jonas Green, of the City of Annapolis, Princer; and to other Purpoles therein

An Act for the Affessment and Payment of the public Charge of this Province.

All which his Excellency the Governor passed into Laws, by sealing them twith the Rt. Hon, the Lord Proprietary his Great Seal at Arms, and Indorsing them severally thus: On Behalf of the Rt. Hon, the Lord Proprietary of this Province, I Will this be a Law.

Agreement that has subsisted between the several Branches of the Legislature, during this long Session of Assembly. And I flatter myself, that our Proceedings will meet with the Approbation of every Man of Sense and Candour, who is a Well wisher to the Happiness of his Country.

I think my elf obliged to return you particularly my Thanks, for the Regard you have shewn to myself; and as I have the Pleasure to think you are fully pertuaded of my Inclinations for your Welfare. I make no Doubt of the Continuance of your good Opinion of me; as I have in Reastry nothing more at Heart, than to be instrumental in advancing the Trade, Riche, and Prosperity of the Province.

The Business of this Session being at an End. I have, with the Advice of his Lordstop's Council of State, thought to prorogue this Assembly to the first Tuesday in October next; and you are to take Notice you are prorogued to that Day accordingly.

So endeth this Session of Assembly, this Eleventh Day of July, in the Thirty-third Year of the Dominion of the Right Honourable C H A R L E S, Absolute Lord and Proprietary of the Provinces of Maryland and Avalon, Lord Baron of BALTIMORE, & C. And in the Year of our Lord, 1747.
