His excellency the governor communicated to the house a letter from his excellency Henry Laurens, Esq; president of congress, of the 24th of April last, enclosing an act of congress of the 23d of the same month, for detecting disaffection, and defeating conspiracies and insurrections in the district therein mentioned, together with a copy of a letter from general Smallwood of the 17th, and copies of two letters to which the general referred: Also a letter, of the 27th of April, enclosing an act of congress of the 23d of the same month, for tapsporting the public provisions and stores across the Chesapeake bay, or otherwise; and an act of the 24th, for granting pardons, and recommending to the several states to pass laws or issue proclamations for that purpose: Also a lest r of the 5th of May, enclosing an act of congress of the 1st of same month, recommending the exempting from militia duty such persons as may be employed in manufacturing military stores, &c. for the use of the United States: Also a letter of the 8th of May, enclosing an act of congress of the 6th of the same month, for making known to the public such parts of the treaty of Paris of the 6th of February last, as congress have judged necessary to be published, and for government of conduct in particular cases: Also a letter of the 11th of May, enclosing copies of an address by congress to the inhabitants of the United States, and copies of a proclamation for restraining the conduct of captains, commanders, and other officers and seamen belonging to American armed vessels: Also a letter of the 26th of May, enclosing an act of congress of the 22d of the same month, recommending to the several states to exempt from militia service, and to disqualify from afting as substitutes, all prisoners and deserters from the British army and navy: A letter from his excellency general Washington, of the 4th of May, upon the subject of secruits ing men in this state for the German battalion; and a letter of the 17th, requesting that five hundred of the militia of this state might be embodied and sent forward to the head of Elk: A letter from general Smallwood of the 18th of May, on the same subject: And a letter from major Lee, of the partizan corps of light dragoons, of the 4th instant, together with his instructions to capt. Lindfay, of the faid corps, for procuring geldings for the light dragoon service, of the inhabitants of the peninsula formed by the Delaware and Chesapeake bays. Which were severally read, and ordered to lie on the table.

Adjourned till 3 o'clock.
