fury and loan-office. That Mr. M'Mechen, Mr. Wilmer, Mr. Alexander, Mr. Reed, Mr. Isaac Henry, Mr. Gaunt, and Mr. Gibson, be a committee to receive and examine any proposal for the establishment of manufactories, and to consider and report the best means for setting on foot manufactories and promoting the trade and commerce of this state.

That Mr. Quynn, Mr. Worthington, and Mr. Maccubbin, be a committee to enquire

what laws have expired, or will expire during this session, or at the close thereof.
