The same of the sa HE house met. Present the same members as on yesterday, except Mr. Hall. Mr. William Brogden, a delegate returned for Anne-Arundel county, and Mr.-James Kent and Mr. William Bruff, two delegates returned for Queen-Anne's county, appeared, and after qualifying in the mode prescribed by the constitution and form of government, took their seats in the house.

The house proceeded to the choice of a speaker, and the honourable William Bruff, Esq;

The house appointed Mr. Frederick Green clerk. ORDERED, That he qualify as such, by taking the several oaths required; subscribing a declaration of his belief in the christian religion, and by taking an oath, that he will honestly, faithfully and diligently discharge the office of clerk to the house of delegates of Maryland, and that he will not reveal or disclose the secrets thereof. \*/f

ORDERED, That Mr. Lloyd and Mr. Chase wait on his Excellency the governor, and inform him that this house is met and ready to proceed on business, and to receive any thing he may think proper to lay before them. They return and acquaint Mr. Speaker they delivered the message.

ORDERED, That Mr. Worthington, Mr. Wilmer, Mr. Quynn, Mr. Deye, and Mr. Craufurd, be a committee to examine and inspect the returns of elections, and report whether they have been made agreeable to the mode prescribed by the constitution and form of government.

That Mr. Lloyd, Mr. F. Gaunt, Mr. Dashiell, Mr. Bayly, and Mr. Potts, be a committee of grievances and courts of justice, and that they have power to fend for persons, papers and

That Mr. Hindman, Mr. W. Stevenson, Mr. Craufurd, Mr. Clagett, Mr. Cramphin, Mr. Dent, and Mr. Ward, be a committee of claims, and to examine into the state of the treasury and loan-office.

That Mr. Quynn, Mr. Potts, and Mr. Worthington, be a committee to enquire what laws

have expired or will expire during this session or at the close thereof.

That Mr. M'Mechen, Mr. Wilmer, Mr. Alexander, Mr. Key, and Mr. Duckett, be a committee to receive and examine any proposal for the establishment of manufactories, and to consider and report the best means for setting on soot manufactories, and promoting the trade and commerce of this state; also to enquire into and report what hath been done by those who have heretofore received encouragement for manufactories.

The house appointed Mr. John Callahan assistant clerk, Mr. Robert Reynolds sergeant at

arms, and Mr. Cornelius Mills door-keeper. Ondened, That they be qualified.

RESOLVED, That the hours of fitting during this session for the dispatch of business be from nine o'clock in the morning until one in the afternoon, and from three till five. The house adjourns till to-morrow morning 9 o'clock.
