Which was read the first and second time, agreed to, and sent to the senate by Mr. John Seney.

The house having qualified agreeably to the conditution and form of government, proceeded to the choice of a governor, and the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported, that the honourable William Smallwood, Esquire, is unanimously elected. Whereupon Resolved, That the honourable William Smallwood, Esquire, be and is hereby declared governor of Maryland.

The report of the committee of elections and privileg was read the second time, and the ques-

tion put, That the house concur therewith? Resolved in the affirmative.
