report thereon.

A petition from Robert Long, of Baltimore county, setting forth, that in virtue of an act passed at November session, 1784, for his relief, arbitrators were appointed to determine concerning the damages which he had sustained by the Principio company, who awarded that he had sustained damages to the amount of nine hundred pounds current money, for the waste of timber and detention of his land; and that it was also awarded, that the state should pay him the sum of £.618 15 0 of the aforesaid sum, being the eleven sixteenths of the said sum in which the state is interested, and also eleven sixteenths of the legal costs of suit, which he had been put to, amounting in the whole to the fum of f. 687 5 9; and praying a resolve authorising the treasurer to pay him the sum awarded in specie, agreeable to the opinion of the arbitrators, or certificates receivable in taxes; was preferred, read, and referred to Mr. Paca, Mr. M'Mechen, Mr. Chase and Mr. Stewart, to consider and report thereon.
