ORDERED, That Mr. Turner, Mr. Faw, Mr. Hollingsworth, Mr. Pattison, Mr. Owings, Mr. Digges and Mr. Perkins, be a committee of claims, and to examine into the state of the treasury; and that they have power to send for persons, papers and records.
