The several county courts, we presume, are suity competent to judge of the necessity of the attendance of their clerks at the court-house or county town. Our amendment, which we adhere to, and which we return with the bill for your recon fideration, gives them the power to direct such attendance every day in the week, if they think it proper, and no doubt they will do it in all the counties where it will be necessary. GENTLEMEN, THE senate, on the 17th instant, returned your bill respecting Mr. de la Fayette, with amendments, fince which your house has favoured this with no communication on that subject.

The object of that bill having met the approbation of both houses, we cannot but conceive the honour of the state thereby committed, especially as our amendments, which apply to the working of the bill only, will not justify, in either branch, its rejection. To stop at this stage of the business, and fuffer the world to ascribe our proceedings to levity, would be too degrading to the representa-
