On motion, Ordered, That Mr. Duckett, Mr. Buchanan, Mr. Digges, Mr. Quynn, Mr. McComas, Mr. Hall and Mr. McPherfore be a committee to inspect and examine the returns of elections, and report whether they have been made agreeably to the constitution and form of go-

vernment; and that they have power to fend for persons, papers and records.

for persons, papers and records.

On motion, ORDERED, That Mr. Hall, Mr. Duckett and Mr. Digges, be a committee to report such rules as are proper to be observed during this session. On motion, ORDERED, That Mr. Quynn inform the reverend Mr. Higinbothom, that the house request he will perform divine service every morning at the meeting of the house. The house adjourns till to-morrow morning 9 o'clock.
