The report on the petition of Charles Gassaway was read the second time, concurred with, and leave given to bring in a bill pursuant thereto. **ORDERED**, That the committee appointed on the said petition prepare and bring in the same.

A petition from Benjamin Dashiell, of Somerset county, counter to the petition of Isaiah Dorman, was preferred, read, and referred to the committee appointed on the petition to which it is counter.

Mr. Ambrose Geoghegan, Mr. James M'Clain and Mr. John Cellar, three delegates returned for Washington county, appeared, and after qualifying in the mode prescribed by the constitution and form of government, and taking the oath to support the constitution of the United States, took their seats in the house.
