BY THE SENATE, DECEMBER 31, 1799.

GENTLEMEN,

THE senate were of opinion that the bill respecting a partition of the estate of John Davidson, deceased, involved in it principles of serious importance in legislation; it occupied their reflections for a considerable time, and the deliberation which they gave it induced them, in a full senate, to reject it. Several of the gentlemen who passed upon that bill are now absent; we therefore think it would be improper to reconsider it, particularly at this advanced period of the session.
