## 16 VOTES AND PROCEEDINGS, November Session, 1800.

Mr. Worthington, from the committee, delivers to the speaker a bill, entitled, An act declaring a road or fireet leading from the Reister's-town turnpike road to intersect Howard-street a public highway; which was read the first time and ordered to lie on the table.

A petition from Henry King, of Somerset county, an alien, praying a confirmation of his title to certain lands, was preferred, read, and referred to Mr. Wilson, Mr. Jones and Mr. Dashiell, to consider and report thereon.

The clerk of the fenate delivers a letter from the governor relative to the act to incorporate a company for the purpose of cutting and making a canal between the river Delaware and Chesapeake bay, and an address from the council, containing an account of their proceedings in reference to sundry acts of the legislature at the last session, endorsed; "By the senate, November 11, 1800: Ordered to be referred to the consideration of the house of delegates.

No person is named by this house in addition to those mentioned in your message.

Whereupon RESOLVED, That Thomas Buchanan, Arthur Shaaff, James Thomas, John Davidson and Samuel

Ridout, Esquires, be, and they are hereby declared to be, the council to the governor.
