

44 VOTES AND PROCEEDINGS, NOVEMBER SESSION, 1800.

The bill to lay out and open a road from Jesse Tomlinson's, on Bradock's old road, to Matthew Ball's, on George's creek, endorsed; "By the senate, November 21, 1800: Read the first time and ordered to lie on the table.

On motion, Leave given to bring in an additional supplement to the act passed at April session, seventeen hundred and eighty-seven, entitled, An act to lay out several turnpike roads in Baltimore county. ORDERED, That Mr. Worthington, Mr. Chapman and Mr. Love, be a committee to prepare and bring in the same.

Mr. Worthington, from the committee, delivers to the speaker a bill, entitled, An additional supplement to the act passed at April session, seventeen hundred and eighty-seven, entitled, An act to lay out several turnpike roads in Baltimore county; which was read the first time and ordered to lie on the table.

A petition from Robert Courtney, of the city of Baltimore, was preferred, read, and referred to Mr. Smith, of Baltimore, Mr. Worthington and Mr. Stansbury, to consider and report thereon.

A petition from William Works, of Cæcil county, an alien, praying a confirmation of his title to certain lands, was preferred, read, and referred to Mr. Forman, Mr. Nelson and Mr. Shriver, to consider and report thereon.

A petition from James Woodland, of Kent county, counter to the petition of John Roche, was preferred, read, and referred to the committee appointed on the petition to which it is counter.

Petitions from William Cooke, William Smith, of the city of Baltimore, and Andrew Banks, of Baltimore county, praying acts of insolvency, were preferred, read, and referred to the committee appointed on petitions of a similar nature.

A petition from John Woodall, of Kent county, praying a confirmation of his title to a house and lot at a place called New-Market, purchased of an alien, was preferred, read, and referred to Mr. Parker, Mr. Chambers and Mr. Angier, to consider and report thereon.
