By redeeming and exchanging the overdue obligations of the State a reduction in the net debt of \$536,170.77 has been effected. The call for redemption of State bonds authorized in 1837 for the Baltimore and Susquehanna Railroad Company, makes the total reduction in the net debt \$724, 170.77.

To use the Governor's own language "this reduction has been made almost entirely by the purchase, redemption and exchange of the matured obligations of the State. Since the last session of the General Assembly, six several and distinct loans owed by the State have matured, aggregating the sum of \$970,595.-35. This will leave ten and one-half cents for the support of the free school system of the State, one-fourth of one cent for the redemption of a part of the exchange loan of 1886, and the balance, five and one-half cents, for the redemption of the defense redemption loan. The last the Governor shows under the improved condition of finances can be reduced to three cents, making a total reduction of

four cents. The total State debt amounts to \$10,-721,642.52. It is offset by resources which leave the net debt \$3,875,965.67. By selling all the State's investments at the present time, its debt would not be more than \$2,500,000, and by 1899 this figure would be a million less, or \$1,500,000. This can easily be provided for, the Governor claims, if his suggestions in regard to taxing the gross receipts of railroads and other corporations are followed. In pursuance of former recommendations in this connection there has been a very satisfactory increase of revenues to the State. A tax of at least two per cent upon the gross receipts of railroad, telegraph and other corporations is recommended.

Extended allusion is made to the recent increase of the capital stock of the Baltimore and Ohio railroad, and the additional revenue which the taxation of this increase would bring to the State. In this connection correspondence between the Governor and the Attorney General is published and it is suggested that the new stock be assessed in order that a case may be made for settlement in the courts. The Governor further shows a disposition to prevent the use of the Baltimore Belt Line's facilities, by the Baltimore and Ohio and Northern Central railroad companies, for the purpose of obtaining

a waiving of the exemptions enjoyed by the latter companies. The Governor whacks at the B. & O. again in giving a review of Chesapeake and Ohio Canal affairs. He regrets that Washington and Cumberland Railroad Company was defeated by the intervention of the courts. The extension of the Australian ballot law is advised as is also the appropriation of a liberal sum for the representation of Maryland at the World's fair.

The message further is devoted to consideration of public education and the various State institutions, and other matters to which we may again advert.
