The Howard County Commissioners' Law -Petition for High License in Ellicott City-The Urange Grove Bridge-Legislative Matters of General Interest. Annapolis, March 3,-The law rela-

tive to the clerk to the Howard county commissioners has passed the legislature and now goes to the Governor for his signature. Its character has already been outlined in THE TIMES. It does not make the clerk treasurer of the county, properly speaking, nor does it alter the present mode of tax collection.

It simply requires the clerk to bond, making provision for better salary. All money received must be deposited in bank without unreasonable delay and the clerk alone can not draw money from bank. A BILL FOR COUNTY SEALS.
