The Free School Book Question Occupying a Prominent Place-Vaporings of a Crank -- Howard's Delegation Have Something to Say-Various Matters of Interest Concerning Legislature Work.

In a newspaper interview Governor Brown said this week that he did not object to free school-books if the State could afford the expenditure, but he did not see how the question could be solved without increasing the tax

"By examining the tables in my messaid he, it will be seen that the resources of the State must be carefully husbanded, and we must not add to our obligations during these uncertain times. In my judgment it would be disastrous to add to the tax levy. I do not pretend to give the exact figures from memory,

but there was something like the sum of \$470,000 available on October 1. This was made up of about \$371,000 received from the general government in discharge of an old obligation, with \$100,000 from the treasury relief loan tax and \$37,000 from the Archer bondsmen. These were inusual receipts, aggregating \$508,000. Now, if free books had been allowed, say \$250,000, and \$100,000 for the new insane asylum with other smaller appropriations vetoed, there would have been a floating debt of nearly half a million dollars. In fact, the State would now be a borrower to defray the running 'expenses of the Legislature. TO TAX MORTGAGES.

Senator Bennett, of Carroll county, Monday introduced a bill providing that all mortgages shall be taxed for the purposes of the State revenue only and at such rate as is now or may hereafter be levied for State purposes. The bill reouires that the clerks of course shall send an account or all unreleased mortgages annually to the county commisioners and Appeal Tax Court of all mortgages held by individual owners, and to the State tax commissioner of all holdings by corporations, to be by him certified to the comptroller, as corporate taxes are now certified, and by the comptroller collected, as is now provided by law for the collection of corporate taxes. Senator Bennett argues that by taxing mortgages sufficient revenue will be raised for an insane asylum and other things needed, and will materially increase the taxable basis of the State.

It provides that any person bringing hay or straw to market who disposes of the same for consump ion west of Gwynn's falls, shall not be subject to any penalty for failure to have it weighed at the western scales; provided the sellers tender to the keeper of the western scales the usual fee for weighing, this fee to be ascertained by the certificate of the person weighing the hay or straw. The bill further provides that any private weigher who shall render a false certificate, and any seller of hay and straw who shall present a false certificate to the State weigher, shall be guilty of a misdemeanor, and upon conviction before a justice of the peace shall be fined five dollars and costs for each


