To Sail for Europe. Mrs. C. Eckert, the letter-hair of the general host of the Howard House, will sail for Europe on Wednesday next, 18th inst., from Baltimore by the German steamer Weimar. Charged with Taking a Horse and Harey. The Baltimore News of Wednesday has a dispatch from Westminster, Md., to the effect that Dr. Kearney, formerly of Sykesville, was arrested at New Windsor Tuesday and lodged in jail in the afternoon on a serious charge. The warrant was issued by Justice Moore of Westminster, and Kearney will have a hearing to-day. Kearney has been living with Jacob Hays, near New Windsor, and on Sunday was taken to the farm of John M. Wagner, a farmer, who left hitched to a store in New Windsor. When he was ready to go home he found that the hitching strap had been cut and the horse and buggy gone. A search for the man who had taken the horse and buggy was made. A telegram was sent to Sykesville and an answer was received that a horse and buggy answering description had been seen there. On Sunday night the horse and buggy was driven back to New Windsor and hitched just where they had been taken from on Saturday night. Suspicion fell on Wagner to cause the arrest of Kearney.

Disaffection About a Will. Steps have been taken to test the validity of the will of the late Thomas Stansfield, of the Third district of Howard county. Mr. Stansfield, who died in January last was the owner of a fine farm and considerable personalty. He left a widow and twelve children, and his will, after bequeathing a life support to the former and \$25,000 to each of the latter, provided that the residue of the estate shall be given to one of his sons, Mr. Thomas H. Stansfield, who is also named as the sole executor. Some of the heirs of the late testator claim that it was through undue influence that the deceased was prompted to make the will. The contents have been examined by J. S. Hensler, of Baltimore, who was in Ellicott City Wednesday in consultation with Senator John C. Rogers, another of their counsel, regarding the preliminary measures to be taken in the case. The will is dated December 15, 1890 and was placed in the custody of the Register of Wills here where it has since remained.
