Some data as to the cost of a good macadamized road may be gathered from the books of the Ellicott City and Clarksville Turnpike Co. The orginal cost was \$2500 per mile. The annual expenditure for repairs is \$150 per mile. The pike is ten miles long. Under the proposed system of road building as discussed in the Court House Tuesday it was not designed to put down roads that would compare with this turnpike. A good serviceable road at the smallest cost is what they were reaching after. The same amount of money now expended on our dirt roads for repairs would probably keep in good repair a road such as was suggested by Gen. Stone at the meeting.

An Attempt to Sell the Line Under a Decree of Court to Satisfy Mortgages. Upon the filing of a petition by William . Marbury, trustee, an order was signed by Judge Wickes in the Baltimore City Circuit Court on Friday of last week giving him the right to file a petition asking for the sale of the Columbla and Maryland Railway, notwith-standing the fact that a bill had been previously filed by the Baltimore Security and Trading Company.

It is claimed, however, that the first mortgage bonds are not held absolutely, but only as collateral for money owed by the company, amounting to not

About 20 miles of track has been laid and a power-house has been built near Ilchester, in Howard county. There is also an uncompleted power-house, near Lakeland, Prince George's county, and a car barn and stables in Washington, as well as valuable real es-

None of the companies in which the Columbia and Maryland holds stocks and bonds, it is claimed, are in a prosperous condition, and several of them are sources of expense. One of the companiesthe Belt Railway, of Washington-is now undergoing foreclosure proceedings. The company has exhausted its resources, and it is claimed has given up all efforts to comp'ete the line. It has neglected to pay the interest on its onds, and has allowed the taxes to increase. This impairs the security of both mortgages, and the holders of the bonds, under agreement, have declared all the bonds due and payable, and ordered the mortgages foreclosed. The petition states that it is thought the best for all parties concerned to do this.

## i family. FARMERS IN COUNCIL.

A Large and Deeply Interested Meeting Consider the Various Phases of the Good Roads Question, That there is a deep and abiding in terest in the question of good roads for Howard county was shown on Tuesday last when the farmers met and counseled together in the Court House here. The meeting was entirely representative in that a large number of farmers were present and was made up of the best brawn and brain of the county. The cading counselor during the deliberations of the meeting was Gen. Roy Stone, of the inquiry division of the U. 3. Department of Agriculture.

Mr. Henry O. Devries presided and John D. Alcock was chosen secretary. During the discussion of the various topics which were considered, Gen Stone said there was no reason why land in this section of Maryland should not be worth \$100 per acre, as compared with farms in Illinois. Here we have a home market, easy transportation, good soil and excellent fertilizers convenient Two-thirds of the farmers' products used by Baltimore and Washington consumers are supplied from other points than Howard and adjacent counties all for the

want of good roads. Gen. Stone said that the question of good roads had been solved in other states and it could be solved in Maryland. He said that state supervision necessary as there was no other way to get around local counteraction and local rejudices which were sure to arise. As to hills no road should be made with a greater grade than four feet in the huntred. Even this grade required a horse to double its efforts to effect ascent.

As to the financial problem connected with road building the speaker said in New Jersey the State paid one-third, the neighborhood ten per cent. and the county the balance. He referred to the road making in California where stone was scarce, notably north of Sacramento where the question had been solved by convict labor, breaking the stone in en closures. Answering an inquiry of Mr. John G. Rogers as to the cost of a serviceable macadam road the speaker said that experience had taught that a dirt and stone side by side was the most approved. OELLA NOTES.

Benjamin Edwards, seventeen years of age, son of Mr. B. D. Edwards, of Oella, met with a horrible accident about eleven o'clock on Friday morning of last week, which resulted in his death a few hours later. The services were conducted by Rev. W. S. Simms, pastor of Patapsco M. P. Church, and his remains were interred in Oella Cemetery. The pall bearers were James Huff, Lee Rockenbaugh, Samuel Sweet, Spencer Wiles, Payton Babylon and Roe Murphy. Undertaker Milton Easton had charge of the funeral. This was the first fatal accident that has oc curred in the Oella mills in the memory of the oldest inhabitant, and much sym pathy is felt for the bereaved family.
