At the request of Hannah Briggs the following deed was recorded the 11th day of February 1804 To wit This Deed of Bargain and Sale made the eleventh day of the second month one thousand eight hundred and four between Richard Thomas jun^r and Deborah Thomas of Montgomery County and State of Maryland of the one part and Hannah Briggs of the same county and state of the other part witnesseth that the said Richard Thomas and Deborah Thomas for and consideration of the sum of Twenty four dollars to them in hand paid at or before the sealing and delivering of these presents the receipt whereof they do hereby acknowledge hath granted bargained sold aliened released enfeoffed and confirmed and by these presents do grant bargain sell alien release enfeoff and confirm unto her the s^d Hannah Briggs her heirs and assigns forever all those two Lots or portions of ground situate and being in the Town of Brookville in the county aforesaid distinguished on the general plat of said Town as surveyed by Richard Thomas jun^r by Lot N^o forty two and Lot N^o forty three adjoining each other To have and to hold the said two Lots with all and singular the hereditaments and appurtenances whatever to the same belonging or in any manner appertaining and they the said Richard Thomas jun^r and Deborah Thomas doth hereby fee themselves their heirs executors and administrators covenant and grant to and with the said Hannah Briggs that they the said Richard Thomas jun^r and Deborah Thomas the said two Lots or portions of ground with all and singular the rights members and appurtenances thereunto appertaining unto the said Hannah Briggs her heirs and assigns forever against them the said Richard Thomas jun^r and Deborah Thomas and their heirs and against all manner of persons what soever claiming the same by through or under them or either of them this or either of their heirs with warrant and forever defend by these presents In Testimony whereof they the said Richard Thomas jun^r and Deborah Thomas hath hereunto set their hands and affixed their seals the day and year above written Signed Sealed and delivered in the presence of }
