At the request of Amos Farguar, the following Deed of Trust was accorded on the 24th day of August 1832, To wit: This Indenture,

made this ninth day of August in the year one thous. and eight hundred and thirty two, between Jehu Price of Montgomery County and State of Maryland of the one part and Amos Farghar of the County and State aforesaid of the other part. Witnesseth: that whereas the said Jehu Price is largely indebted to sundry creditors on Book accounts, notes and Judgments, and Whereas he fears some part of his creditors may distress his property and sell it under value, so that his other creditors in that event, might lose all or as part of their just claims. And Whereas a majority of the said Jehu Price's creditors did appoint Roger Brooke William Woodward and Caleb Bentley, to appoint as trustee for the benefit of said creditors, and Whereas a majority of them did appoint the said Amos Farghar, as trustee for the benefit of the said Jehu Price's creditors. Now this indenture witnesseth that in consideration of the premises, and of the sum of five dollars current money at or before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, the said Jehu Price, hath given, granted, bargained and sold, and by these presents do give, grant, bargain and sell unto the said Amos Farghar, all his right, title, interest, claim and demand, of, in and to as certain piece or parcel of land called The Resurvey on Part of Leek's Lot, lying in the County and State aforesaid, containing twelve and three quarter acres of land, more or less, with all the buildings and appurtenances thereunto belonging, consisting of a woollen Factory, dwelling house & other out houses and the Machinery thereto belonging. To have, and To hold, the said Land and premises with its appurtenances thereunto belonging, unto him the said Amos Farghar, his heirs and assigns forever, to and for the use, trusts & purposes herein after mentioned. and for the consideration aforesaid, the said Jehu Price do give grant, bargain and sell unto the said Amos Farghar, all his personal and mixed property, now in his possession, or that can be obtained by law, consisting of the following articles and so forth, six bedsteads, beds and bedding, one mantle clock, looking glass, desk, chest of drawers, cherry dining table, large poplar table, chairs, workstand, candle stand, pair andirons, shovel and tongs, large cupboard, glass china & common cupboard ware, carpeting, Hookstove with its boilers, Iron wash pot 2 small ditto, dutch oven, skillet, teakettle, gridiron, bake iron, flesh fork & Ladle, pair candle sticks, knives & forks, tin ware, 3 Buckets, 2 tubs, 1 pale, 2 potters ware, part of Keg of staves, churn, cow, buffalo, wheelbarrow, one sorrel horse, Carriage & some harness, one swift broad shearing machine, Stanley narrow ditto, gig mill or napper, 2 Cylinders, 1 wool picking machine, fullers brush, press papers, as parcel of wool rolls, 20 pounds half blood merino Yarn, 15 pounds coarse ditto, about 80 yards cotton warp about 40 ditto, coarse ditto, 3 Sattinette Shuttles, 3 or 4 Needles or gears, 2 nine hundred steel needs, one 7 hundred d. 2 1/2 inch 7 hundred steel red & Vears,

one 7 hundred, 530, & 450 cane reeds, and gears. 3 Brod reeds and gears 2
 Shuttles for broad Loom. 3 narrow looms, one pair pack cards. 1st Blanket

 brazil wood, Niquarago? Tarzels. 3 yd^s gray broad cloth, 20 $\frac{1}{2}$ yd^s Sattinets,
 lot of Sattinets now in Balt^o with William Loney, one sleigh, 3 drawing chains,
 hip straps, pair hames, bridle & Collar, 2 Shovels, one spade, mattock, ^{hoe} pick
 one axe, mallet & pair wedges, lot of old iron, half keg spearl ash, ^{ten} plate
 stove, 2 drums, Stove pipes, a lot of barrels, cutting box & some eye. Straw,
 2 Stacks of hay, small lot of potatoes, and cabbages, and other garden stuff
 also all my accounts on Books, To Have and To Hold the same described
 property unto the said Amos Farguhar, his heirs and assigns, for the purposes
 herein after expressed, that is to say, in Trust for the benefit of said Jehu Price's
 creditors, that the said Amos Farguhar, may sell and dispose of the same or
 any part thereof, and the proceeds to be paid to the lawful creditors of said Price,
 after deducting all expenses which may be incurred by the trustee, in fulfilling
 his trust, the said Jehu Price reserving to himself all the overplus of the pro-
 ceeds, after paying costs and charges, and the just claims of his creditors. In
